A motion was made by William Tulko and seconded by Christia Li Roberts to approve the minutes of February 25, 2019, as presented. The motion passed unanimously (10-0 vote).

Public Comments and Introduction of Council Meeting Attendees:

Public Comments were given by Aubrey Campbell, Martin County Healthy Start Coalition to announce the 26th Annual Luncheon Invitation for May 10th. Cher Fisher, Ted Astolfi, Carol G. Houwaart-Diez, Elliot Paul, and Tracey Etelson spoke on behalf of Helping People Succeed-Language and Literacy Connection urging Council to continue their funding.

Old Business:

A. 09/30/2018 Auditor's Report (Draft) presented by J.W. Gaines from Berger, Toombs, Elam, Gaines & Frank

A motion was made by James Campo and seconded by William Tulko to approve the draft Auditor's Report of the Children's Services Council of Martin County for year ending September 30, 2018, as presented by J. W. Gaines of Berger, Toombs, Elam, Gaines & Frank. The motion passed unanimously (10-0 vote).

The approved 2018 Audit Report will be posted on the Children's Services Council's website.

New Business:

A. CSCMC Funded Provider Presentation by Helping People Succeed – The Language & Literacy Connection (verbal) – given by Julie Zygmun, Early Language and Literacy Coordinator.

No motion required.

B. 2019 CSCMC Annual Tenant Lease Renewal with Treasure Coast Buddhist Cooperative

A motion was made by James Campo and seconded by Christia Li Roberts to approve staff's recommendation for the renewal of the 2019 CSCMC Tenant Lease for Treasure Coast Buddhist Cooperative commencing on May 1, 2019 ending December 31, 2019, as recommended by staff. The motion passed unanimously (10-0 vote).

C. Martin County Board of County Commissioners (MCBOCC) – Budget Amendment

A motion was made by William Tulko and seconded by Laurel Hopper to approve the Budget Amendment in the amount of \$48,263 to be effective May 1, 2019. The motion passed (8-0 vote) with two opposed.

D. Dunbar Tuition Assistance Program (TAP) – Partnership Funding

A motion was made by Sarah Heard and seconded by Laurel Hopper to approve the 2018-19 Partnership Funding to Dunbar Center, Inc. in the amount of \$13,750 for the TAP-Tuition Assistance Program utilizing 2018-19 CSCMC Program Reserve Funds. The motion passed unanimously (10-0 vote).

E. Boys & Girls Club, iMAP – Match Funding

A motion was made by Sarah Heard and seconded by Laurel Hopper to approve Match Funding to Boys & Girls Club of Martin County, Inc. in the amount of \$60,000 for the iMAP program (Individuals Making Active Progress), utilizing the reallocation of ELC Match funds from CSCMC's 2018-19 FY budget. The motion passed unanimously (10-0 vote).

F. City of Stuart Community Services Department & Martin County Board of County Commissioners – CSCMC Policy 1.1d Waiver Request (taxing authority)

A motion was made by Christia Li Roberts and seconded by William Tulko to approve waiver to the CSCMC Program and Funding Policies document, Section 1.1 Funding Eligibility, Policy 1.1d that limits funding of taxing authorities to two years for the City of Stuart Community Services Department and for Martin County Board of County Commissioners. The motion passed unanimously (10-0 vote).

G. Martin County Board of County Commissioners' Waiver Request for 2019-20 CSCMC Policy and Contract Language Modifications

A motion was made by Christia Li Roberts and seconded by William Tulko to approve the requested language modifications to CSCMC Policies 5.6 Insurance; 5.8a Confidential Information; 5.11 Community Outreach; and 5.16 Public Records Law Compliance; and to CSCMC Contract Sections VI. Termination #2; Section VII. Liability, #1 and #2; and Section XV. Public Records Law Compliance for the 2019-20 CSCMC Contract with Martin County Board of County Commissioners, pending Council's funding approval. The motion passed unanimously (10-0 vote).

H. 2019-20 Continuing Contracts Funding Recommendations

A motion was made by Christia Li Roberts and seconded by James Campo to approve the 2019-20 recommended funding allocations up to \$3,777,994 for the 22 programs currently funded by CSCMC in 2018-19, per the attached 2019-20 Continuing Contracts Funding Recommendations chart. The motion passed unanimously (10-0 vote).

I. 2019-20 Program Development/New Initiatives Funding Recommendations

A motion was made by Christia Li Roberts and seconded by James Campo to approve the 2019-20 funding totaling \$499,561 for the following three programs: ELCIRMO /Bridge to Continuity program (\$50,000); Tykes & Teens, Inc./General Mental Health program (\$409,308); and Early Head Start Match (\$40,253). The motion passed unanimously (10-0 vote).

J. 2019-20 Request for Proposals (RFP) Funding Recommendations Success In School and Life: Youth Development/Academic Support Focus Areas: School-to-Work/Job Connection and Out-of-School Time

A motion was made by Christia Li Roberts and seconded by Sarah Heard to approve funding allocations to 9 RFP programs for a total of \$1,888,088 per attached 2019-20 CSCMC Request for Proposals Funding Recommendations chart. The motion passed unanimously (9-0 vote).

K. Prime Time of Palm Beach County, Inc./Martin County Out-of-School time Quality Improvement Initiative – 2018-19 Targeted Funding Recommendation

A motion was made by Sarah Heard and seconded by Laurel Hopper to approve Targeted Funding to Prime Time of Palm Beach County, Inc. in the amount of \$99,660 for the Martin County Out-of-School Time (OST) Quality Improvement Initiative. Funding would utilize \$23,067 Future Program Services Expansion Funds, \$49,000 2018-19 unused funds for the ELCIRMO-Bridge to Continuity program, and \$27,593 2019-19 unused funds for an Early Head Start Match program. The motion passed unanimously (9-0 vote).
