Applications that propose programs, models of care, curricula, interventions, etc., that are Research-Proven/Evidence-Based and that offer meaningful improvement as measured through validated instruments, data-driven results, etc., may rank higher within the competitive 2021-2022 CSCMC Healthy Children Request for Proposals (RFP) process.</p> <p>In considering an application, determine if the proposed program aligns with the 2021-2026 CSCMC Strategic Plan and is consistent with the 2021-2026 CSCMC Healthy Children Strategic Investments.</p> <p><i>(For the complete 2021-2026 CSCMC Strategic Plan, refer to the CSCMC website under menu heading 'About CSCMC'/Strategic Plan.)</i></p>


